Marie Pattullo: We certainly agree with the need for rapid movement forward - te "E" of the "EPDP" still stands!

Rubens Kuhl:Marie, if that was true, the vote would not have been deferred...

Ayden Férdeline: This same sense of urgency was not shared when it come to delaying this vote.

Ayden Férdeline:Exactly Rubens

Julf Helsingius: The urgency was due to the GDPR deadline. That is now resolved.

Maxim Alzoba: what happened, happened, so we need to go further

Marie Pattullo:Rubens - the deferral was to allow discussion. So yes, it is true.

Ayden Férdeline:+1 Michele - the current pace is unsustainable

Marika Konings:please note that the 'expedited' in EPDP refers to the difference in the initial phase of the EPDP compared to a PDP. It does not refer to the overall timeline for delivering an Initial or Final Report. In phase 1, this timeline was actually driven as the result of an external timeline.

Michele Neylon:sorry if I was faint

Julf Helsingius:Indeed. Most of us are not paid to do the EPDP

Terri Agnew:finding the line

Michele Neylon:phone literally won't take the \* 6 anymore

Julf Helsingius: Marika +1

Rubens Kuhl: What would be a per week hour limit that would be reasonable?

Ayden Férdeline: thanks for the clarification there Marika

Julf Helsingius: 2-3 hours per week

Ayden Férdeline:max 1 call per week

Rubens Kuhl:Ayden, that would make hard for sub-teams to exist.

Maxim Alzoba: 1.5 calls?

Ayden Férdeline: i understand that, but i do not think subteams are really needed given how small the membership is of the EPDP

Rubens Kuhl:That's why a total hours per week limit is more adequate for a wholesale level, and then let leadership decide how to to divide it.

Ayden Férdeline:most issues are going to be discussed in plenary anyway

Tatiana Tropina:okay understood.

Tatiana Tropina:thanks Keith.

Ayden Férdeline: i do not object to leaving this to EPDP leadership to ultimately slice and dice, but as a general rule, this should be treated now as a regular PDP

Rubens Kuhl:May 25, 2020.

Tatiana Tropina: new hand

Rubens Kuhl: I think it needs to be a ceiling.

Marie Pattullo:Support Keith. And the issues in phase 2 are vital to us - including those that were deferred there (in good faith...)

Rubens Kuhl:Without a ceiling, people will be scared of joining.

Maxim Alzoba: or it should not be expected ...but

Rubens Kuhl: I think whether F2F meetings will be had is something people will factor in deciding. So this needs to be set from start.

Ayden Férdeline:good comments Darcy

Ayden Férdeline:agreed Rubens, and dates being set early are important, particularly for those who need visas...

Rubens Kuhl:My personal view is to not have F2F meetings outside ICANN meetings.

Rubens Kuhl:But if there are going to be, it needs to be specified. 1, 2, 3...

Ayden Férdeline: The NCSG would be unable to support efforts to revisit the carefully constructed membership composition of the EPDP.

Ayden Férdeline: It seems the term "good faith" is more a term of art than something with a rigid definition, like I had once thought.

Marie Pattullo: The Charter says that "the third deliverable of the EPDP Team shall be an Initial Report outlining a proposed model of a system for providing accredited access to non-public Registration Data, followed by a Final Report following review of public comments." We're still in the EPDP. Don't re-open the Charter, and don't slow down this important work, please.

Rubens Kuhl: This is the content of the notice sent to contracted parties:

Paul McGrady:Let's find a new word beside "dependencies" - it has led to a bit of confusion in the RPM/Sub Pro context. We need to be careful not to introduce that kind of ambiguity on the EPDP Phase 2 work.

Keith Drazek:Fair point, Paul

Rubens Kuhl: "DAP enables access to current registration data and was created as an eventual replacement for the WHOIS protocol. It delivers registration data like WHOIS, but its implementation will change and standardize data access and query response formats. ICANN organization worked with a discussion group of gTLD registries and registrars to draft, seek, and take into account public comments prior to publication of this gTLD-RDAP Profile."

Marika Konings:@Paul - do you have any suggestions for a better word?

Paul McGrady:@Marika - how about "interactions"

Marika Konings:in certain cases it is waiting for input that is provided from someone else (e.g. legal counsel) - not sure if that is the same as 'interaction'?

Paul McGrady:@Marika - we should view it like a pharmacist would. Drug A is not necessarily dependent on Drug B (unless it specifically is) but there could be an interaction between Drug A and Drug B that is either good or could kill the patient. We need to be aware of policy interactions, whether good or bad...

Maxim Alzoba:@Paul, Chemistry and Biology is not applicable to operational and legal issues Rafik Dammak:@Paul dependencies in term of projec management, that finalziation of A requires of the finalziation of B

Marika Konings:right, in certain cases interactions may be more appropriate, but in other cases the EPDP Team did specifically identify what would need to be provided first before an informed discussion could be had.

Rubens Kuhl:Dependency == reliance

Paul McGrady:@Maxim - metaphor and analogy are bedrock to liberal arts thinking. See, I used "bedrock" and I wasn't even meaning to make a reference to geology

Elsa Saade:lol

Maxim Alzoba: @Paul, no objections

Darcy Southwell: We have to be careful. There are times that dependencies are significant and work may be totally reliant upon that dependency. Not nearly as flexible as an "interaction."

Paul McGrady:@Darcy - agree, but those need to be ID'd so that we don't accidently label something a dependency when it really is just an interaction to be thought through.

Elsa Saade:@Paul on a side note I think chemistry in this space definitely makes sense sometimes. The other definition of chemistry. lol

Elsa Saade: (on a less serious note that is)

Maxim Alzoba:design based on not yet delivered results of EPDP ... seems to be an interesting idea at least

Marika Konings:Please note that we just received a request to move the TSG engagement to Sunday instead of Wednesday so that may get swopped around.

Marie Pattullo:Thanks Keith - yes, it's equally important.

Paul McGrady:@Elsa, LOL!

Elsa Saade:Yes! The charter is clear efinitely

Elsa Saade: I'm talking more practically

Paul McGrady: A WG team can be burned out by going too slowly just as much as going to quickly.

Elsa Saade:thanks Keith! Makes complete sense.

Tatiana Tropina: yes please reasonable is a keyword. The phase 1 pace is unreasonable now.
