Jeff Neuman:

Thank you. This is Jeff Neuman. So we have a very low turnout today. We have a couple of registries - registrars and a noncommercial representative, which is I think a little bit low to actually hold a meaningful call although I'm sure we could have a good discussion between the few of us.

So what I am discussing are the topics that we were planning on covering today. And I think what's going to happen is we will plan on covering those topics next week. I will be actually in a plane at the time of the call next week so I have asked James Bladel if he could step in for next week and cover these topics.

So the topics that we were going to cover today that we will cover next week are on foreign translations. We have talked about on the last call when foreign translations should be or must be done.

And the question that still remains on foreign translations is how to ensure that we can do these without delaying the PDP process, and how that fits in for example if there is a public commentary that is opened up for 20 days but it turns out it's going to take us 5-10 days to get the translation of the executive summary for example or the policy recommendations done.

How do we sync up the time periods to make sure that all the comments are considered or A, that we get all the comments and B, that the comments are all considered? So James has that's a good point - James has put on the wiki chat that we shouldn't call them foreign translations because while they may be foreign to me they are not foreign to everyone else.

So translations - thank you James. So translations of the documents so that's one topic. And then the second topic is to just basically go over the different thresholds that we have decided through this entire process, the voting thresholds. And I will send around a document. I'll run it by ICANN staff first to make sure to do a check.

But I believe the only areas for the PDP that we have come up with voting thresholds are for when an issue can be raised, the council can vote, when initiating a PDP and there are thresholds with that. There is voting on approving the charter and then a question that remains of does that same voting threshold apply when you're modifying the charter?

So if the working group comes back and then says we want to change part of the charter, which actually is something we're going through now with the VI, the vertical integration working group, what is the standard or what is the voting threshold for the council to modify a charter?

So that's one thing we need to talk about, which may be the same as the standard for voting to approve a charter. But again, that's a topic to discuss. The next area is a final vote. So when the board must adopt a policy and a subset of that is what do we recommend the board does with a majority vote as opposed to a super majority?

Or let's say one house wants a certain policy and the other house votes it down. What are the obligations on the board? And then finally just to confirm that what we mean by super majority vote, which is currently 66% of the members present at a meeting.

I'm sorry, it shouldn't be - it's basically 66% - actually never mind. I took the old threshold. There is a super majority threshold, which is a majority of both houses. So anyway, it's defined actually of both houses. I'll put that definition in. I'm blanking right now on what that definition is right now but I will make sure we have the right definition to make sure that it is still the current definition.

So James, I think those are the topics for next week. Does that sound like a plan for the people that actually came to this call?

Liz Gasster: And Jeff, this is Liz. If I could just point out that on the document that
