Coordinator: Thank you. I'll join into the call.

Liz Williams: Thank you.

Coordinator: (Unintelligible) just momentarily. No one is (unintelligible) already.

Liz Williams: Thank you.

Coordinator: Liz go ahead, thank you.

Liz Williams: Thank you operator.

Okay. Glen, would you mind just do me a quick roll call, please.

Glen de Saint Gery: Certainly Liz.

Liz Williams: Thank you.

Glen de Saint Gery: We have on the call Kelly Smith, Mike Rodenbaugh, J. Scott Evans, yourself and myself.

Liz Williams: Lovely. Okay, that's great. Just then so the purposes of the recording, I

just wanted to let everybody know that who might listen to the

recording and read the transcript, not read the transcript but listen to

the recording that we haven't received any of the first draft of the

templates.

And I just wonder if everyone could just give me a quick update about

when we think those would be available from your perspective. J.

Scott, do you want to kick off?

J. Scott Evans: I think it would be - it's going to be another seven to ten days.

Liz Williams: Okay. And so you're entailing you're doing that one, aren't you?

J. Scott Evans: That's right.

Kelly Smith: Yeah. And then...

Liz Williams: Yeah. Mike, what's so your status?

Mike Rodenbaugh: That sounds about right to me as well.

Liz Williams: Yeah. Okay. Anyone else?

That was three. So that's two (unintelligible)...

J. Scott Evans: I think Margie Milam one of them.

Liz Williams: No. I didn't hear her.

J. Scott Evans: She's on the call but was handling one of them.

Liz Williams: Yes, she was handling one of them. She has got the template.

Everyone got the template and have – has everything they need to do

it.

J. Scott Evans: Okay.

Liz Williams: But it's not – they're not being distributed yet. Is it then reasonable to

assume that the next call that we would have which is on the 21st, which is in the Fort Knox time? Is it feasible to expect that we could have the first draft of those within seven days? Or at some point before

the call so that people could read them?

J. Scott Evans: Yes, the 21st today is the seventh.

Liz Williams: Yup. And the next call would be on the 21st. And it would be helpful if

everyone distributed them prior to the call...

Liz Williams: ...so we can actually read them prior to the call.

J. Scott Evans: Okay, I would.

Kelly Smith: J. Scott, unfortunately I'm at vacation from this week Thursday through

the 17th. So, I can get you the notes I've...

J. Scott Evans: Yeah. Why don't you just give me your notes and I'll put it together.

Kelly Smith: Sorry about that.

J. Scott Evans: That's so. You can't help that is, my fault for my computer glitches.

Liz Williams: Mike, how does that suit you?

Mike Rodenbaugh: That sensed me just fine. I need to get that done, so.

Liz Williams: Okay.

J. Scott Evans: If I could get something Liz, I'll – my goal would get something out

between the 16th and the 18th...

Liz Williams: Okay.

J. Scott Evans: ...which would get between five and three days.

Liz Williams: Yeah.

J. Scott Evans: Depending on when I get it out.

Liz Williams: Cool. In that case, I wonder if it wouldn't be helpful because Kristina is

on vacation this week as well. And I had warned her violently not to

dial in to any calls that we're not...

Kristina Rosette: (Accepted).

Glen de Saint Gery: ...(unintelligible) completely necessary. And I wonder if it's not

sensible then to send out a note to the group to say that the first draft

will be discuss on the 21st of August. And that sending them around

sometime prior to the 18th of August would be helpful for everybody.

J. Scott Evans: Yes.

Liz Williams: So that works for everyone?

J. Scott Evans: Yes Ma'am.

Kelly Smith: (Unintelligible) have question.

Liz Williams: ...as possible Kelly that I expect would really help potential applicant.

Just for your benefit too, Kelly and J. Scott, yesterday on the GNSO Committee Meeting, Ute Decker brought up the wordings which refers to this work in the conversation about (those). It was the final call of the committee yesterday between is now adjourn about the final wording of the part A which refers to the right protection mechanism.

And I clarify to her that these are things that potential applicants may wish to consider in the application process. And everybody on the call agreed that they might use and correct this if I'm wrong because you and other person on the call that it remains a none of an obligatory requirement for potential applicants to adopt any or either or all of the potential tools that you guys might come up with.

So the easier reduce Kelly to read them and to compare them and to make decisions about them. I think the greater the chance is that potential applicants – that applicant would potentially use them.
